IMPORTANT NOTES:

Access and voting mandates

The annual meeting is public, but only EFFORTS members may join the debates and Full members have the right to vote. I remind Associate members of the Association that they have the right to participate at Annual Meetings but not to vote.

Proxy voting

<u>Proxy voting may be important because the General Meeting is only valid if over half the</u> <u>Full Members are present or represented (see statutes).</u>

I would be very grateful, if all full members, who are unable to be present at this meeting, would sign and return the attached proxy form in PDF to the Nominating Committee as soon as possible: <u>info@efforts-europe.eu</u> (one proxy form per member). Proxies should be registered with the Nominating Committee at least 7 days in advance of the General Meeting (1st November 2018).

Each member present can accept a <u>maximum of two proxy votes</u>. The number of proxies to be accepted by members of the Board is not limited.

Voting procedures (statutes and internal rules)

- All decisions are taken by a simple majority of votes present and represented, unless this is decided otherwise by the Statutes.
- If there is a tie, the Chairman or the Board Member, who replaces him fulfilling this function, has a casting vote.

I sincerely hope to welcome you in Venice at our EFFORTS conference and Annual General meeting and look forward to exchanging ideas and making plans for the future of our military heritage.
