What a ride it was. This European Year of Cultural Heritage 2018, now coming to a close (but its message will be heard over the next years), was also the first fully operational year of EFFORTS.

As the newly confirmed President of EFFORTS, with our new Board, I am proud that in this year we grew from an aspiring group of professionals to an official European association of more than 40 representations of Europe's fortified heritage. EFFORTS is now being recognized as the European **professional association of walled towns and fortification sites**. We spoke at congresses in Croatia, France, Germany, Belgium, Montenegro and the Netherlands. We met with Members of the European Parliament, Commission and Committee of the Regions, we created the European Fortress Day, the EFFORTS Award, presented the **EFFORTS Venice Declaration** on the post-2018 EU policy period on military built heritage, organized a well-attended and interesting Annual General Meeting and **Congress at Forte Marghera in Venice** and organized our European Liaison office in Brussels, at 200 meters from the European Parliament.

For all of this I wish to express my warmest thanks to all of you who worked and volunteered to put our priorities to the forefront of European policy.

And we continue in **2019, with the second edition of European Fortress Day** and its goal to reach 100 participants. Come and join us !

Next year we are also increase our national memberships and tighten our international and partnerships, meeting for instance in January with the International Fortress Council. Part of that meeting will also be the first meeting of the newly set up EFFORTS working party, the **EFFORTS European Funding Professionals Network**. We learned that it is important to join in a network our member's 'European funds specialists'. Through the EFPN, we can communicated on an immediate basis and directly on European choices, chances and change.

Finally, we can note 23 May 2019 in your agendas as the date of the next **Board meeting**. This time I am happy to host it in the city of Bergen op Zoom. Soon we will inform you on the venue of the next **EFFORTS Congress** in the fall.

After all this work, Christmas is a time for reflection and joy. A time to spend with family and friends. I therefore wish you the best of holidays and will be happy to see you in the New Year !

EFFORTS ANNUAL CONGRESS and ANNUAL GENERAL MEETING

One year after the first meeting in Spandau, Germany, EFFORTS' AGM and Annual Congress were hosted by Forte Marghera in Venice, Italy. Introduced by the representants of the Venice city and regional authorities, by messages of Silvia Costa, Member of the European Parliament and Ádám Karácsony, Member of the Committee of the Regions - both rapporteurs on the new cultural programmes of the European Commission, together with a message of support by Sneška Quaedvlieg-Mihailović, Europa Nostra secretary-general, the Congress focused on expert feed-in into the draft EFFORTS Venice Declaration (see below). The Congress participants visited also the newly set up EFFORTS European Knowledge Center on Fortifications at the Forte Marghera site. EFFORTS will work with its members and with the International Fortress Council on how to roll out a European network for this Center.

EFFORTS DECLARATION OF VENICE : Six Proposals on the Future of Fortification Heritage in Europe

*“We, members and interested stakeholders of fortified heritage in Europe, believe that, at the end of the European Year of Cultural Heritage 2018, fortified heritage offers an opportunity to make a **positive contribution to several EU priorities and United Nations Sustainable Development Goals**. The following seven propositions highlight the **potential of this specific type of heritage in Europe and European programmes**. They demonstrate how to preserve European military architecture through active involvement of all stakeholders. The importance of fortification heritage places it next to religious buildings, industry, historic houses and all other built and architectural European heritage.”*

Such is the introduction of the EFFORTS Declaration, developing **6 action points** for the attention of the European institutions and prepared by a 's Hertogenbosch – led working party :

1. Understanding fortified heritage increases European unity
2. Fortifications offer educational and economic opportunities
3. Adapting fortification use is combating climate change
4. Fortified sites provide sites for employment and social development
5. Fortified heritage improves access to culture and quality of life
6. Fortifications are smart actors of urban and landscape development

The six EFFORTS propositions emphasize the awareness of the great cultural educational, research, social, environmental and economic-tourism assets of European fortified heritage. They are the conclusions of the annual **EFFORTS congress ‘From stronghold to welcoming arms’ in Venice**, 8-9 November 2018. With Europa Nostra in its Berlin Call to Action, that has been co-signed by EFFORTS, we state that a European *“Action Plan, mentioned in the New European Agenda for Culture recently adopted by the European Commission, must be prepared and implemented with full involvement and engagement of all public and private stakeholders, including civil society. This future Action Plan must be interconnected with other key EU policy agendas and priorities”*.



EFFORTSsnapshot : Andrea Bonifacio



Andrea Bonifacio is a Venice based expert in Economics and Management of Arts and Culture. After a long time working as a financial consultant specialized in SME sector, he was involved in the development process of the reuse of Forte Marghera (Venice) and has been many years operating in international cooperation and in projects funded by EU programmes, mostly focused on management and development arts and heritage. He oversaw the creation of cultural activities (music, books, theater, art exhibitions, workshops), establishing links with institutions and culture representatives in Europe and beyond. He was in charge of the EFFORTS treasury in 2018 and of the relations between EFFORTS and Forte Marghera Foundation. The Foundation is the organization managing the fortress, where in two newly refurbished buildings the EFFORTS European Knowledge Center basis was created. This new center is at the disposal of local and international partners. Andrea stays active in EFFORTS, but is replaced as EFFORTS treasurer by his colleague and Forte Marghera director, Stefano Mondini, host, together with Andrea, of the EFFORTS 2018 Congress (see above).

EFFORTS at Future of Religious heritage bi-annual congress at UNESCO, Paris, France



EFFORTS at Architect Council of Europe (ACE) congress on 23 November in Leeuwarden, Netherlands

On 23 November, the Architects' Council of Europe (ACE) organised in Leeuwarden a conference on the **Adaptive Re-Use and Transition of the Built Heritage**. This event took place in the framework of the EYCH and related in particular to the Initiative 4 on "Heritage in Transition". On the invitation of DG Culture, the European Network ACE organised on this occasion a panel discussion in order to take stock of the lessons learned over the EYCH on the "adaptive re-use" theme. EFFORTS representative and European heritage expert Huibert Crijns was invited to speak at the panel, together with colleague European associations.



« We were very pleased to have for this session representatives from several members of the Heritage Alliance 3.3, namely the European Federation of Fortified Sites (EFFORTS), Europa Nostra, Future for Religious Heritage (FRH) and the European Route of Industrial Heritage (ERIH) », said Peter Obajtek, from the ACE representation in Brussels (see photo).

On this occasion, a Declaration entitled « **Preserving and Enhancing the Values of our Built Heritage for Future Generations** » was presented. 

After a preliminary meeting between ERRIN's and EFFORTS Brussels liaisons, ERRIN informed its members at its 11 September 2018 Opening Science and its 16 September Experience Economy working groups dealing with Creative industries, on EFFORTS activities and interests, that is: the EFFORTS annual congress, the Walls&Peace Brussels start event of Atlantikwall Europe and EFFORTS and the EFFORTS continuous partnership search between regions in fortified heritage sectors. For this, the EFFORTS Brussels representative was invited to present EFFORTS at 27 November working group meeting, centered on the future Horizon Europe's Cultural Heritage cooperation. - **EFFORTS collaborates in European Framework for Action on Cultural Heritage**

The European Commission asked EFFORTS to share with our members the first-ever **European Framework for Action on Cultural Heritage**, presented by the EU Commissioner for Education, Culture, Youth and Sport at the Closing conference of the **European Year of Cultural Heritage 2018** in Vienna on December 7.

*“During the European Year of Cultural Heritage 2018, over 6.2 million people took part in more than 11,700 events organised across 37 countries. The European Commission implemented 10 European Initiatives as the main policy input for the Year, and substantial funding for cultural heritage was made available through different EU programmes. To ensure that the European Year has a lasting impact beyond 2018, the Commission has presented a set of over 60 actions related to the promotion and protection of cultural heritage in the longer term. The Framework for Action re-affirms and puts into practice the principle of mainstreaming of cultural heritage in different EU policy areas, and is the first document to set out an **integrated approach to***

cultural heritage at European level", says Hughes Becquart, policy officer at the Commission's DG Culture EYCH2018 unit.

One cluster of actions (cluster n°5) is dedicated to the adaptive re-use of heritage buildings. The Commission is thankful for EFFORTS' and other association's contributions to the EYCH initiative "Heritage in Transition", which has made it possible to focus a number of follow-up actions on adaptive re-use.
