A WORD FROM THE PRESIDENT

Dear members and sympathisers,



With the 2018 **European Year of Cultural Heritage 2018** up and running, EFFORTS is engaged in organizing, in its first year of activity, focusing on adaptive re-use of fortification heritage and the meaning of fortification heritage today. I am proud to announce to you the start, in September 2018, of the yearly 'EFFORTS European Fortress Day', in 2019 joined by an 'EFFORTS Prize'. The Dutch Foundation Liniebreed Ondernemen will manage the communication of this EFFORTS event. Read more about this in this Newsletter.

We also organize with the network Atlantikwall Europe on 28 June a debate in the European Parliament in Brussels and, following in the afternoon on that day, the workshop for our members on how to establish a partnership for EU funding, at our Brussels liaison office. The programs for both events are forthcoming. Registration can be done with our EU office. Efforts will participate in a workshop during the Berlin Heritage conference in June in Berlin and will organize a workshop in October in Brussels, both on adaptive re-use.

Based on present participations in EU consultations, EFFORTS is preparing its **position paper**, emphasizing the challenges ahead in Europe. At the end of the European Year on Cultural Heritage 2018, the EFFORTS General Assembly will be presented the document proposal. In the meanwhile, feel free to use the EFFORTS presentational abstract in your network (see website).

EFFORTS board members Andrea and Karen participated in April the organization of the **Conference on Synergies between heritage, tourism and digital culture**. More on this in this newsletter. We welcomed our Croatian partners as member and are ready to organize our common interest in Europe.



End of November, the EFFORTS Annual General Meeting will be organised in Venice. It is important to stress that we will include a public event in this AGM, touching on important issues that challenge fortification sites in Europe today and tomorrow. More details will be sent in the next weeks.

EFFORTS PRESENTATION

European Federation of **Fortified Sites**

EFFORTS is the first European network of fortified towns, forts and defensive lines.

EFFORTS defends the interests of private, local and regional authorities, develops and exchanges innovative knowledge to maintain military stronghold heritage and represent this important part of Europe's history towards the EU institutions and beyond. The foundation for Efforts was laid during the final conference of the At Fort Interreg IVC project in Helsinki (FIN 2014). At the conferences in Den Bosch (2016 NL) and Spandau (2017 Berlin – DE) and based on long year cooperation between most of the partners, EFFORTS made sure that right from the start of the European Year of Cultural Heritage 2018, the association is up and running. Working with representatives from all European countries, EFFORTS:

- establishes a permanent European network of fortified heritage sites
- sets up practical partnerships between scientific experts, policy makers, enterprises and practitioners in order to allocate means for innovative development of sites
- provides an international exchange of information and research expertise on innovative use of fortified heritage
- recognizes the tangible and intangible values and social and economic significance of fortified heritage
- supports members in the development of fortification heritage
- understands and promotes the regeneration and redevelopment of fortified sites and their surrounding urban and rural landscape
- promotes accessibility for citizens and meaningful sustainable reuse of fortified heritage
- highlights and raises the profile of fortified heritage, such as walled towns, fortresses and defensive lines.

Synergies between Heritage, Tourism and Digital Culture

Fortified sites, being precious testimony to the collective memory, represent a unique expression of Europe's cultural heritage. They demonstrate the intrinsic need to defend borders in the past, however, today they are symbols of our common European history and unite Europe instead of dividing it. Military heritage represents the strategic awareness of the European countries throughout the ages. Whether a walled town, a fortress, or a defense system, the sites often have an isolated position within spatial context. Nevertheless, fortified heritage is being discovered as a means of improving economic performance, people's lives and living environments. Both governments and citizens use innovative and creative approaches to unlock the possibilities for growth and development that fortified heritage holds across Europe.

Not only fortified heritage but heritage in global, share issues on redevelopment, re-use, maintenance and environment - specific problems.

Solutions can be complex and expensive and cover a large area of interests e.g. archaeology, spatial & urban development, tourism, economy, traffic & public transport, ecology... They often demand creative and innovative solutions.

Creativity and innovation is of all time.

3 examples of an integrated approach and EU-cooperation:

- Integration of fortified heritage, visitor and transport facilities in an urban context: Den Bosch (the Netherlands) and Antwerp (Belgium)
- Balancing between being a historic UNESCO site, tourist destination, place to work and place to live: Suomenlinna, Helsinki (Finland)
- Bringing military heritage sites to life with Augmented Reality. Cooperation the Netherlands, Finland, Lithuania and Estonia. (EU-project proposal)

EFFORTS EUROPEAN FORTRESS DAY



EFFORTS has asked the Dutch foundation Liniebreed Ondernemen to assure the marketing and promotion of the first yearly to be held EFFORTS EUROPEAN FORTRESS DAY (EFD) in September 2018. It is no coincidence that this event is organized in the period EU countries plan Open Monuments Day. This way, a firm wish from EFFORTS members at its first Annual General Meeting in November 2017 has been put on the rails. It is important to stress that EFD is a great opportunity to harness Europe-wide fortification sites' interest, to present these views to the larger public and decision makers, and to present a European platform and network that can run its candidacy for EU and national support. To this effect, in 2019 the EFFORTS PRIZE will be annexed to the EFD. EFFORTS hopes all members will join efforts to participate all in this first, maybe small-scale, but gradually increasing, pan-European event. More info on EUROPEAN FORTRESS DAY soon. On common decision by H.A. 3.3, EFFORTS formulated **3 key policy messages** which EFFORTS would like to convey on occasion of the EYCH 2018 as a contribution to the drafting of the "Alliance Manifesto" to be signed in Berlin :

- 1. Important is to influence now the post-2020 European policy challenges. Specific attention must be given to the impact of European legislation on historical fortified sites, particularly what energy, habitat, air quality, water and waste are concerned. These opportunities will render possible an innovative re-use of historical sites.*
- 2. This re-use potential of fortified sites is particularly important for opportunities concerning energy transition for SMEs, creative industries and educational projects. They are the result of innovative national, regional and local policies and need careful interventions with reference to monument and landscape policies.*
- 3. European historic fortified sites are landmarks of our heritage. The preservation and maintenance objectives and procedures for fortified sites should be discussed at a European level, with reference to the peculiarities of fortifications. This can be used as a base for European restoration and re-use guidelines."*

EFFORTS executive board members Karen Gysen and Andrea Bonifacio were invited to attend the international conference on cultural heritage issues, **“Sharing the Future of Cultural Heritage – Synergies between Heritage, Tourism and Digital Culture”**, held in the UNESCO city Dubrovnik, Croatia from April 10-11, 2018.



The conference, co-organized by HUPG (Croatian Association of Historical Cities), its member towns (Croatian city governments), the host-city Dubrovnik and the French association Sites & Cites, was supported by EFFORTS, among other foreign non-governmental organizations. HUPG common mission is to improve the quality of life in historical centers, cities and tourist hubs for the joint benefit of local communities and visitors. We strive to provide the prerequisites needed for a quality co-existence of historical heritage and contemporary trends, despite the many challenges.

In line with the European Year of Cultural Heritage 2018, the conference provided examples of good practices and insights into specific activities and measures in response to the contemporary challenges facing local authorities and other relevant agencies.

As collateral events, the EFFORTS delegation met *Jelka Tepšić*, the Deputy Mayor of Dubrovnik, and Zrinka Raguz, head of the Department for EU-funds, discussing about the opportunities of cooperation. EFFORTS also subscribed a partnership agreement with Jakov Vetma, the President of HUPG, as a new EFFORTS member.



EFFORTS, was the first speaker at the conference. Karen Gysen explained the need of an active European network of fortified towns, forts and lines of defense in Europe, EFFORTS' birth, its goals, how it works and some examples of an integrated approach and EU-cooperation by some of its members in the field of Creativity and innovation: the integration of fortified heritage, visitor and transport facilities in Den Bosch (the Netherlands) and Antwerp (Belgium), the Suomenlinna (Helsinki, Finland) experience in balancing between being a historic UNESCO site, tourist destination, place to work and place to live and the cooperation between the Netherlands, Finland, Lithuania and Estonia in a new EU-project proposal on the potentials of Augmented Reality in bringing military heritage sites to life with. Andrea Bonifacio added some information's on the network financial sustainability perspectives. He also pointed out how EFFORTS already provide service like the cooperation project coordination and the knowledge centers.

DUTCH FORTRESS DAYS BROUGHT MANY VISITORS TO GRAVE

7 and 8 of April was a crowded weekend for the Dutch walled town of Grave where the annual Dutch Fortress days took place. Thousands of re-enactors played the 'Siege of Grave'. The Fortress days take place every year in a different walled town in The Netherlands.



This year the Efforts member Grave hosted the event. Knights, old vessels, guilds and troubadours brought the town's history to life. For this national event the entire old town was temporarily a car-free zone. Efforts board member Huib van Olden visited Grave and congratulated mayor Lex Roolvink to the occasion.





EFFORTSNAPSHOT

In this space we will present in every newsletter a member or other person active in or for EFFORTS and their activities today. After Rafaël Deroo, EFFORTS EU-liaison in Brussels, we give the floor to Andrea Theissen:



A history and German philology major and expert in historical exhibition projects, she was assigned in 1997 with the directorate of the cultural department of Berlin-Spandau becoming responsible for the historical fortifications and more specifically the renaissance fortress of the Citadel, the Fort Hahneberg with its origins in the 19th century and the reduits of the Spandau bastion fortifications . Until 2017, Andrea established the museums at the Citadel as well as in Spandau and planned exhibitions of supra-regional significance. For more than twenty years, she has been active in national and international fortification networks as the *Deutsche Gesellschaft für Festungsforschung* and the *IFC (International Fortress Council)* and has participated in EU projects for the preservation and re-use of fortresses. From all of these the Interreg IV C project AT FORT was particularly delighting for her– and this not only because of the outstanding results, but especially because of the close cooperation with the project partners. That is why Andrea is very happy to contribute her services to EFFORTS and the new EFFORTS European Fortress Day, in order to amplify and expand this network.

To celebrate the European Year of Cultural Heritage, the Zuiderwaterlinie Events Foundation organizes a major 'peace jump' in June on behalf of its partners. The Zuiderwaterlinie is a 165 kilometers ancient military defense line, running straight through the Dutch province of North-Brabant. It connects eleven historical fortified towns and their beautiful surroundings. The parachute jump takes place on Saturday, June 23. Dozens of parachutists - including a large number of military personnel - will be dropped over the five fortified positions of the Zuiderwaterlinie in Bergen op Zoom, Breda, Den Bosch, Heusden and Grave. Once the parachutists have landed, they receive a warm welcome in the Zuiderwaterlinie cultural festival. Local cultural associations will participate in the two-day festival (23 and 24 June) to bring the Zuiderwaterlinie back alive through storytelling, theatre, dance and other artistic expressions.
